**Advertising:** UGNO is promoted through online and print publications, email list serve databases, posters & flyers and social media. Vendors need to submit form & payment 3 weeks in advance in order to be listed on promotional material.

**Set Up & Parking:** Vendors can park and unload their vehicles for set up along St. Croix Trail. After unloading vehicles must be moved to the back lot of Afton House Inn. Street parking should be reserved for guests & customers. Set up between 4pm — 4:45pm. Be ready by 5pm!
